**ITEM 100 — GOVERNING PUBLICATIONS**

This tariff is governed by the following described publication and by supplements thereto or reissues thereof:

ODFL 100 Series (Rules Tariff), issued by Old Dominion Freight Line, Inc. (see NOTE)  
ODFL 101 Series (United States Mileage Table), issued by Old Dominion Freight Line, Inc.  
ODFL 115 Series (Points of Service), issued by Old Dominion Freight Line, Inc.  
ODFL 128 Series (Fuel Surcharge), issued by Old Dominion Freight Line, Inc.  
NMF 100 Series (Classification Governing), issued by the National Motor Freight Traffic Association, Inc., agent:  
HGB 100 Series (Mileage Guide)  
HGB 105 Series (Zip Code Mileage Guide)

NOTE—The provisions and/or charges of any rule in ODFL 100 Series may be excluded from application by specific reference in documents referring to this Tariff.

**ITEM 130 — PARTICIPATION IN TARIFF**

Request for participation in this tariff must be submitted to ODFL's corporate office for approval. Once approved, Customer will receive confirmation of participation and rates will be made available to customer.

**ITEM 150 — APPLICATION OF TARIFF**

The provisions of this Tariff apply only as follows:

1. Customer must request a rate and obtain a quote number electronically, supplying at least the following information:
  - a. Cubic feet or linear feet occupied by the shipment
  - b. Shipper and consignee name and full address (city, state, and ZIP code)
2. Customer must use One Rate One Time booking API to schedule/dispatch. The digital BOL and Pro number provided in the API response must be submitted.
3. If key shipment attributes from the rate request are found to have changed, such as zip codes, weight, cubic feet, linear feet, or accessorial charges, ODFL may, at its sole discretion, apply otherwise applicable or negotiated rates to the shipment.
4. Carrier's liability for cargo loss or damage shall be as provided in ODFL 100 Series, Item 594. Optional Higher Level of Carrier Cargo Liability may be purchased per ODFL 100 Series, Item 574.

Violation of any of the above provisions on a shipment rated from this Tariff may result in ODFL applying otherwise applicable LTL rates and rules to the shipment.

**ITEM 565 — FRACTIONS OF CUBIC FEET**

In determining the number of cubic feet to be charged, ODFL shall use the cube information provided on the bill of lading to determine the number of cubic feet to use. However, ODFL reserves the right to measure and correct the cubic feet based on its physical examination of the freight. Charges may not be assessed using fractions, such as 3.2 cubic feet. All fractions will be rounded UP to the next whole number.

**ITEM 646 — NON-APPLICATION OF RATES**

If a shipment moving under provisions of this tariff is found to exceed any of the following measurements, ODFL may, at its sole discretion, apply the otherwise applicable or negotiated rates to that shipment:

- 23,000 pounds per shipment
- 4,000 pounds per pallet
- 1,500 cubic feet per shipment
- 27 linear feet per shipment
- 95 inches in length or width per pallet
- 99 inches in height per pallet

The provisions of this Tariff apply only under the following conditions:

- Applies only on shipments handled direct via ODFL within the 48 Contiguous States.
- Freight must be palletized and securely fastened to pallets. Rates provided shall not apply if the driver is required to sign for pieces in lieu of pallets.

The provisions of this Tariff shall not apply on shipments:

- Subject to pallet exchange/returns.
- Contains Articles of Excessive Dimension as described in ODFL 100 Series Item 670-5.
- Picked up or delivered on Saturday, Sunday, or a Holiday as described in ODFL 100 Series, Item 752-3.
- Picked-up or delivered to Convention Centers, Exposition Centers, temporary warehouses or hotels, for exhibitions or trade shows, meetings, events or conferences as described in ODFL 100 Series, Item 752-7.
- Requiring services as described in tariff ODFL 661 Series, Speed Service On Demand.

Violation of any of the above provisions on a shipment rated from this Tariff may result in ODFL applying otherwise applicable LTL rates and rules to the shipment.

**ITEM 870 — RULES, REFERENCE TO**

This tariff is governed, except as otherwise provided herein, by rules tariffs listed in Item 100. Where a rule is published in this Tariff, covering the same service as a rule published in rules tariffs listed in Item 100, such rule published herein, to the extent of its application, will apply in lieu of the rule published in rules tariffs listed in Item 100.

**ITEM 880 — NON APPLICATION OF RULES LISTED IN ODFL 100 SERIES**

Shipments rated from this Tariff shall not be subject to ODFL 100 Item 610-1 (Minimum Charge for Low Density Freight) or ODFL 100 Item 390 (Capacity Load Rule).

**ITEM 2000 — ADDITIONAL RULES AND REGULATIONS**

1. Rates stated in dollars and cents per shipment ("USD").
2. Rates are valid for 10 days after rate request.
3. If at any time ODFL must pay a loading or unloading allowance for a shipment moving under provisions of this tariff, such charges will be applied in addition to rates provided.
4. These rates and rules will not alternate with any other pricing provisions published for the payor of the freight charges.
5. Shipments rated from this tariff are subject to all rules and accessorial charges as published in ODFL 100 Series. Go to [www.odfl.com](http://www.odfl.com) for a complete rules summary.
6. Carrier's liability for cargo loss or damage shall be as provided in ODFL 100 Series, Item 594. Optional Higher Level of Carrier Cargo Liability may be purchased per ODFL 100 Series, Item 574.
